LISTS A AND B WILL BE PUBLISHED REGULARLY ON THE WEBSITES OF: MINISTRY OF FOREIGN AFFAIRS: WWW.MAEC.GOV.MA MINISTRY OF HEALTH: WWW.SANTE.GOV.MA MINISTRY OF TOURISM: WWW.AVIATIONCIVILE.GOV.MA THE TWO LISTS WILL BE REGULARLY UPDATED AT LEAST TWICE A MONTH AS NEEDED.</p> <p>3- TRAVELERS COMING FROM COUNTRIES ON THE LIST A WHETHER THEY ARE MOROCCAN NATIONALS, OR FOREIGNERS ESTABLISHED IN MOROCCO, OR CITIZENS OF THOSE COUNTRIES OR FOREIGNERS RESIDING MAY HAVE ACCESS TO MOROCCAN TERRITORY IF THEY HAVE A CERTIFICATE OF VACCINATION OR A NEGATIVE PCR TEST TAKEN AT MOST 48 HOURS BEFORE ARRIVAL.</p> <p>4- TRAVELERS COMING FROM COUNTRIES ON THE LIST B MUST HAVE A NEGATIVE PCR TEST TAKEN AT MOST 48 HOURS BEFORE ARRIVAL, THEN SUBMITTING THEMSELVES TO A SANITARY QUARANTINE OF 10 DAYS IN A SPECIFIC HOTEL DEFINED IN THE CIRCULAR NOTE OF DGAC/DTA ADDRESSED TO AIRLINES SERVING MOROCCO. AIRLINES MUST BE VIGILANT WITH REGARDS TO PASSENGERS IN TRANSIT WITH TWO TICKETS, THE FIRST TICKET IS FOR TRAVELLING FROM A COUNTRY OF LIST B TO A TRANSIT COUNTRY OF LIST A AND THE SECOND TICKET IS FOR TRAVELLING TO MOROCCO. THESE PASSENGERS ARE CONSIDERED BELONGING TO LIST B UNLESS THEY CAN PROVE THAT THEY HAVE STAYED AT LEAST TEN DAYS IN THE COUNTRY OF LIST A. THE PASSANGERS CAN ONLY BE ALLOWED TO BOARD IF THEY HAVE A VOUCHER PAYMENT FROM THE HOTEL RESERVATION. THE PASSANGERS FROM COUNTRIES ON THE LIST B WHO STAY MORE THAN 10 DAYS IN COUNTRIES ON THE LIST A ARE EXEMPT FROM THE SANITARY QUARANTINE.</p> <p>5- CHILDREN YOUNGER THAN 10 YEARS ARE EXEMPT FROM A NEGATIVE PCR TEST.</p> <p>6- AUTHORIZED FLIGHTS MUST RESPECT THE CONDITIONS OF ACCESS TO NATIONAL TERRITORY IMPOSED BY THE COMPETENT MOROCCAN AUTHORITIES.)</p>
